Scheme for Waiver of Admission fees, tuition fees etc. for Students taking admission in H.S. & Degree Courses

A. Applicability:

Category of students eligible under the scheme:

- Students whose parental annual income must be less than Rs. 2.0 lakh from all sources will be eligible to avail this scheme.
- If either of the parents (Mother or Father) of the student is working in the State Govt./Central Govt./Semi Govt./State or Central Govt. undertaking such student shall not be eligible to get free admission under this Scheme.

B. Proof of Income/Documents required:

- An Income Certificate from the Local Circle Officer or from the Head of the institution previously attended. The income certificate so submitted by the candidates will have to verified by competent authority within one year and action as per law will be taken against anyone where submission of false certificate is established.
- A declaration from the student that neither of the parents (Mother or Father) is an employee of State Govt./Central Govt./Semi Govt./State or Central Govt. undertaking. If such a declaration is found to be false the admission shall be cancelled and fees shall be realized from such students. The Director of Higher Education, Govt. of Assam will make random check of Income certificate and disciplinary action will be taken against the students.
